1. Males and females ages between fifteen years and the legal drinking age may apply to become a Youth member of the Club in accordance with the procedure for ordinary membership.
2. Youth members shall;
Be entitled to join any Club Adjunct and engage in activities within the Adjunct.
Be bound by the sale of the Liquor Act and Club Rules.
Not be eligible to take part in any Membership Draws or other Club Promotions.
Not be eligible to take part in Meetings and Elections of the Club.
3. On reaching the legal drinking age, Youth members are eligible to apply for ordinary membership.
4. Members shall automatically lose their Youth Membership status three months after reaching the legal drinking age or upon admission as an ordinary member.
5. As a Youth Member you are not permitted to sign anyone in, be at the club unsupervised after 8pm, or be at the Club in school uniform after 5.00pm

JUNIOR MEMBERSHIP (12 To 15 Years)

1. Males and females ages between twelve years and fifteen years may apply to become a Junior member of the Club in accordance with the procedure for ordinary membership.
2. Junior members shall;
Be entitled to join any Club Adjunct and engage in activities within the Adjunct.
Be bound by the sale of the Liquor Act and Club Rules.
Not be eligible to take part in any Membership Draws or other Club Promotions.
Not be eligible to take part in Meetings and Elections of the Club.
3. Not permitted to be in the Club unsupervised.
4. Members shall automatically lose their Junior Membership status three months after fifteen years old at which time they can request for youth membership.
5. As an Junior Member you are not permitted to sign anyone in, be at the club unsupervised after 8pm, or be at the Club in school uniform after 5.00pm
